

Factors affecting the performance of the Sudanese balance of payments During the period (2000-2015)



Abstract

The study dealt with the factors affecting the Sudanese balance of payments during the period and the reasons for the failure of the policies that were adopted in order to (2015 - 2000) restore balance to it. The study also showed the most important factors that affected the balance of payments during that period. The study hypotheses through the study model using (Eviews statistical analysis program). The study reached several result, including that the monetary economic variables represented in the money supply, exchange rate, inflation and foreign debt have a significant impact on the balance of payments during the study period.

The study recommended that appropriate economic policies be taken to address imbalances in the balance of payments and work to achieve low inflation rates and exchange rate stability to improve the balance of payments situation.
